# 40 Years of Caring for Life

- ♦ September 1979 Incorporated and the first patient was accepted; four patients were served in 1979.
- ◆ January 1992 Officially changed the name to Hospice of the Chesapeake, Inc.; more than 1,200 hospice patients have been served since 1979.
- ♦ October 1996 Opened the first hospice residence in Maryland named The Creston G. Tate and Betty Jane Tate Foundation Chesapeake Hospice House.
- ◆ April 2000 Awarded certificate of need for hospice care in Prince George's County.
- ♦ July 2006 Opened the James and Arloine Mandrin Chesapeake Hospice
  House in Harwood.
- May 2009 Launch of The Life Center, an umbrella brand for all grief support programs.
- ♦ April 2011- Launch of Chesapeake Kids, an umbrella brand for all children's programs.
- ◆ August 2011 Purchase of seven-acre campus in Pasadena and Mandrin House relicensed as inpatient care center as an alternative to hospital admissions.
- ♦ July 2012 Launch of Chesapeake Palliative Medicine to serve patients living with complex illness; 2,430 hospice patients were served in 2012.
- December 2015 Opening of Rebecca Fortney Inpatient Care Center on John & Cathy Belcher Campus in Pasadena.
- ◆ August 2018 Opening of the Hussman Palliative Care Center and the Lovelace Education & Training Center on the John & Cathy Belcher Campus in Pasadena

#### Did you know?

We cared for 4 hospice patients that first year in 1979 and in 2017 we cared for 3,123 hospice patients and their families.
